

INSTRUCTIONS FOR FILING PETITIONS FOR CLOSING OF ROADS, ALLEYS AND VACATIONS OF RIGHTS-OF-WAY IN PINECREST, FLORIDA

REQUIREMENTS:

Two (2) copies of the petition properly executed by <u>ALL</u> property owners abutting on the road, alley, or right-of-way sought to be closed, or who are affected by the proposed road closing, or vacation, shall be filed with the Planning Director, Pinecrest Municipal Center, 12645 Pinecrest Parkway, Pinecrest, Florida 33156.

- 1. Check for \$200.00 payable to the Village of Pinecrest to cover cost of publishing notices, recording fees and cost of administrative review.
- 2. Twelve (12) copies of a location and survey sketch prepared by a Florida registered land surveyor, (2 of which shall be sealed), showing and describing the road and roads sought to be closed and showing all encroachments, improvements and utilities.
- 3. Petitioner should attend Village Council meeting at time of road closing hearing.

PETITION TO CLOSE ROAD, ALLEY OR VACATE A RIGHT-OF-WAY

Pursuant to Sections 336.09 through 336.12, Florida Statutes, the Village Council, with respect to property under its control, may in its own discretion, and of its own motion, or upon the request of any agency of the state, or of the federal government, or upon petition of any person or persons, are authorized and empowered to: (1) vacate, abandon, discontinue and close an existing public or private street, alleyway, road, highway, or other place used for travel, or a portion thereof, and to renounce and disclaim any right of the Village and the public in and to any land in connection therewith; (2) renounce and disclaim any right of the Village and the public in and to certain land, or interest therein, acquired by purchase, gift, devise, dedication or prescription for street, alleyway, road or highway purposes other than lands acquired for state and federal highway; and, (3) renounce and disclaim any right of the Village and the public in and to land, other than land constituting, or acquired for, a state or federal highway, delineated on any recorded map or plat as a street, alleyway, road or highway.

PROCEDURE TO CLOSE A ROAD, ALLEY OR VACATE A RIGHT-OF-WAY

- 1. Preliminary meeting between the applicant(s) and the Planning Director to analyze the petition.
- 2. If the petition is considered appropriate by the Planning Director, the applicant(s) must submit a petition signed by all property owners abutting the street, alleyway, road, highway, right-of-way or land to be closed or abandoned and a \$200.00 processing fee.
- 3. If the application is complete, the Planning Director schedules a public hearing before the Village Council.
- 4. The Village Council holds a public hearing on the petition. The Council may approve, disapprove or modify the petition.
- 5. The Village publishes a notice of the adoption, one time only, within 30 days following its adoption, in one issue of a newspaper of general circulation published in the County.

The petition to be submitted by applicant(s) must include the following:

- □ A complete and accurate legal description of the street, alleyway, road, highway, right-of-way or land, or a portion thereof, sought to be closed.
- □ Evidence of the title or interest of the Village and the public in and to the above described street, alleyway, road, highway, right-of-way or land, or a portion thereof, stating whether public interest was acquired by deed, dedication or prescription, and setting forth where deed or plat information is recorded in the public records.
- □ Survey or location sketch accurately showing and describing the above described street, alleyway, road, highway, right-of-way or land, or a portion thereof, its location and relation to surrounding property, and all encroachments and utility easements.
- □ Letters from utility companies that have utility easements in the road.
- □ Schedule of all property owners abutting the above described street, alleyway, highway, road, right-of-way or land, or a portion thereof, certifying that in the event that this petition is granted that said property owners will not be prevented from access to and from their property or otherwise adversely affected.
- □ Certification that the above described street, alleyway, road, highway, right-ofway or land, or a portion thereof, is not a part of any state or federal highway and was not acquired or dedicated for state or federal highway purposes; and, that such street, alleyway, highway, road, right-of-way or land, or a portion thereof, is under the control and jurisdiction of the Village Council of the Village of Pinecrest.
- Grounds and reasons in support of this petition stating why the petition should be granted.
- □ The signatures of all of the abutting property owners of the above described street, alleyway, road, highway, right-of-way or land, or a portion thereof, which is presented for closure.
- Payment of the public hearing fee in accordance with adopted fee schedule.
 Please, make checks payable to the Village of Pinecrest.

PETITION TO CLOSE ROAD, ALLEY OR VACATE A RIGHT-OF-WAY

The undersigned pursuant to Sections 336.09 - 336.12, Florida Statues, hereby petition the Mayor and Village Council to vacate, abandon, discontinue, and close an existing public or private street, alleyway, road, highway, or other placed used for travel, or a portion thereof, and to renounce and disclaim any right of the Village and the public in and to any land in connection therewith; or to renounce and disclaim any right of the Village and the public in and to certain land, or interest therein, acquired by purchase, gift, devise, dedication or prescription for street, alleyway, road or highway purposes; or to renounce and disclaim any right of the Village and the public in and to certain land delineated on a recorded map or plat as a street, alleyway, road, or highway.

The undersigned hereby certify:

1. LEGAL DESCRIPTION: The complete and accurate legal description of the road, right-of-way or land sought to be closed is as follows:

PUBLIC INTEREST IN ROAD: The title or interest of the Village and the public in and to the above described road, right-of-way or land was acquired and is evidenced in the following manner (state whether public interest acquired by deed, dedication or prescription and set forth where deed or plat is recorded in public records):

ABUTTING PROPERTY OWNERS: The following constitutes a complete and accurate schedule of all owners and occupants of property abutting upon or adjacent to the above described road, right-of-way or lands and all persons who will be affected by the closing and abandonment thereof (all interested or affected persons must either sign this petition or sign a written consent):

- 6. NO FEDERAL OR STATE HIGHWAY AFFECTED: The undersigned certify that the above described road, right-of-way or land is not a part of any state or federal highway and was not acquired or dedicated for state or federal highway purposes; and that such road, right-of-way or land is under the control and jurisdiction of the Village Council.
