I have read and agreed to the requirements of these codes/ordinances provided.

I acknowledge requirements of Village of Pinecrest standards/codes: (see below).

I acknowledge that any violation of these codes/ordinances can result in civil citations being issued.

- All proposed work within the public ROW requires a Public Works Permit. This includes placing new sod or planting trees.
- All proposed trees in the ROW will be planted a minimum of 7' from the edge of pavement to the face of the tree and will be of a type, size, and spacing as approved by the Village arborist. Arborist contact information is: Rick Carr <u>ccarr@pinecrest-fl.gov</u>
- No shrubs nor bushes of any type are permitted to be planted in the ROW.
- No IRRIGATION, LIGHTING, or ELECTRICAL COMPONENTS of any kind may be installed in the ROW.
- No pesticides, insecticides or fertilizers are to be applied/used in the ROW.
- Metal trimming tools (edger's) are not to be used to trim next to the street nor around street trees.
- Any and all grading as required by the Public Works Department will follow the latest Public Works swale detail.
- No yard debris will be displaced by any manner (electric/gas blowers, etc.) from private property to the ROW nor from the swale to the street.
- No materials of ANY kind will be stored for any length of time on the public swale.
- ALL work conducted in the ROW will implement the applicable FDOT Standard Index 600 Series for MOT.
- Debris piles (bulk waste) placed in the ROW for County pick up must adhere to the County's requirements for size and disposition of the debris. Their website is: <u>Bulky Waste Pickup (miamidade.gov)</u>, and requirements summarized here:

- Place your trash at the curbside **no more than three days in advance** of your bulky appointment date. If you place your trash at the curb on your appointment date, it must be at the curb by 7 a.m.
- Trash should be placed within 10 feet of the street and <u>at least</u> **five feet** from mailboxes, parked cars, trees, utility poles, sprinkler heads and other obstructions that might be damaged by the collection equipment.
- A 15-foot clearance is required from the ground to the lowest hanging tree branch or power line.
- Tree limbs in the pickup pile should be no more than five feet long.
- Only up to three cubic yards of wooden fence is allowed.
- Debris piles placed in the ROW cannot obstruct the sight triangle of driveways nor intersections. As a general rule, placement of debris piles on corners is prohibited. For corner houses that abut a section line or half-section line road it is preferred that the debris pile be placed on the minor street.
- Debris piles CANNOT obstruct sidewalks

Items NOT allowed:

- Tires
- TVs
- Garbage food and kitchen waste
- Auto parts
- Central air units
- Fiberglass used for insulation
- Free-flowing liquids
- Household chemicals
- Oil-based paint
- Rock, dirt or sand
- Any single item weighing more than 150 pounds

# Leaf Blower Regulations:

Leaf blower means any device used, designed, or operated to produce a current of air by electricity or other means to push, propel, or blow lawn, tree, or plant cuttings, refuse, or debris. Such devices shall not produce a current of air by fuel.

Leaf blowers. The use or operation of any leaf blower, unless said machine has a stamp from the manufacturer or testing laboratory certifying a rating of no more than 65 dBA.

#### 15-1(d)1.a

Unlawful accumulations of materials; disposal and storage of goods.

It shall be unlawful for any person or persons to place, sweep, scatter, throw or dump or cause to be placed, swept, scattered, thrown or dumped, for any purpose whatsoever, any refuse, rubbish or trash of any kind, any wrecked, derelict or partially dismantled motor vehicle, trailer, boat, machinery, refrigerator, washing machine, plumbing fixture, furniture or similar article, any garbage, household trash, commercial trash, industrial waste, yard trash, tree trimmings or similar material in or upon:

Any road, street, parkway, sidewalk, park, lake or bank of any river, stream, lake, watercourse or pool, or any portion thereof, within the limits of this village, or upon any village owned real property, except under the rules and regulations promulgated for the handling of such material, at a designated place, and with the consent of the village or its designated agents or employees. Garbage shall be placed in secured containers (i.e. garbage cans) in order to prevent disturbance of contents by animals.

It shall be unlawful for any person or entity to throw, drain, run, allow to seep, or otherwise discharge or allow to be thrown, drained, seep or otherwise discharge any organic or inorganic materials into or onto swales, alleys or streets. This shall not apply to individual single-family or duplex homeowners that may wash their own vehicles on their own property, provided that all runoff is contained on the property. Draining of pools must be contained within the property and must not spill onto public property. Dumping of wash buckets, chemicals, grease, liquid waste is prohibited on public or private property.

#### Sec. 16-149 - MANAGEMENT OF GRASS CLIPPINGS AND VEGETATIVE MATTER.

In no case shall grass clippings, vegetative material, and/or vegetative debris be washed, swept, or blown off into stormwater drains, ditches, conveyances, water bodies, wetlands, or sidewalks or roadways. Any material that is accidentally so deposited shall be immediately removed to the maximum extent practicable
