

We, the undersigned, County Court Judge SHELLEY J. KRAVITZ, **Chairperson**, County Commissioner KATY SORENSON, **Member**, and Supervisor of Elections DAVID C. LEAHY, **Member**, constituting the Board of County Canvassers in and for said County and appointed pursuant to the provisions of Florida Statute 101.6103—Mail ballot election procedure—, do hereby certify that we met on the 2nd day of May, A.D., 2001, and proceeded to publicly canvass the votes cast for the charter amendment questions herein specified in the **VILLAGE OF PINECREST SPECIAL ELECTION** held on the 1st day of May, A.D., 2001, as shown by the returns on file in the office of the Supervisor of Elections. We do hereby certify from said returns as follows:

CHARTER AMENDMENT 1 ELIMINATION OF AREA RESIDENCY REQUIREMENT; QUALIFYING

The Village Charter currently requires a candidate to reside continuously for at least one year in the respective residential area the candidate proposes to represent on the Council prior to the time of qualifying. The Charter Revision Commission has recommended that the Charter be amended to provide that a candidate reside in the respective residential area the candidate proposes to represent on the Council at the time the candidate seeks to qualify for election.

Shall the above described amendment be adopted?

The whole number of votes cast was 3,082, of which number:

YES received 940 Votes

NO received 2,142 Votes

**CHARTER AMENDMENT 2
ELECTION TIES**

The Village Charter does not contain a provision for resolving a tie vote in an election. The Charter Revision Commission has recommended that the Charter be amended to provide that if a tie vote occurs in an election, the tie vote shall be decided by drawing straws.

Shall the above described amendment be adopted?

The whole number of votes cast was 3,060, of which number:

YES received 1,659 Votes

NO received 1,401 Votes

**CHARTER AMENDMENT 3
ELIMINATION OF TRANSITION PROVISIONS**

The Village Charter provides for transition provisions solely intended for the purpose of effecting the incorporation of the Village and the transition to the new municipal government. The Charter Revision Commission has recommended that the Charter be amended to eliminate expired transition provisions referenced throughout the Charter.

Shall the above described amendment be adopted?

The whole number of votes cast was 3,033, of which number:

YES received 2,651 Votes

NO received 382 Votes

**CHARTER AMENDMENT 4
CHARTER REVISION COMMISSION**

The Village Charter currently provides that the Village Council shall appoint a Charter Revision Commission in December every ten (10) years and provide for a special election by May of the following year. The Charter Revision Commission has recommended that the Charter be amended to require the Village Council to appoint a Charter Revision Commission in March every six (6) years beginning in 2006 and provide for an election by October of the same year.

Shall the above described amendment be adopted?

The whole number of votes cast was 2,983, of which number:

YES received 2,459 Votes

NO received 524 Votes

**CHARTER AMENDMENT 5
SELECTION OF VICE MAYOR**

The Village Charter currently requires that the Village Council shall elect one of its members as Vice Mayor on an annual basis. The Charter Revision Commission has recommended that the Charter be amended to require the Village Council to adopt an ordinance creating a procedure for the selection of the Vice Mayor.

Shall the above described amendment be adopted?

The whole number of votes cast was 3,031, of which number:

YES received 2,157 Votes

NO received 874 Votes

**CHARTER AMENDMENT 6
DEATH OF CANDIDATE; QUALIFYING**

The Charter Revision Commission has recommended that the Charter be amended to require a new qualifying period and special election, if necessary, in the case of a candidate's death, withdrawal or removal from the ballot following the end of the qualifying period and in the event such action leaves fewer than two (2) candidates for an office.

Shall the above described amendment be adopted?

The whole number of votes cast was 3,029, of which number:

YES received 2,662 Votes

NO received 367 Votes

**CHARTER AMENDMENT 7
TERM LIMITS**

The Village Charter currently limits the length of service of the Mayor and Councilmembers to two consecutive terms and a maximum of eight consecutive years. The Charter Revision Commission has recommended that the Charter be amended to limit the length of service of the Mayor and Councilmembers to three consecutive terms and a maximum of twelve consecutive years (maximum of fourteen consecutive years for Seat 2 and Seat 4 members elected in 1996).

Shall the above described amendment be adopted?

The whole number of votes cast was 3,007, of which number:

YES received 856 Votes

NO received 2,151 Votes

**CHARTER AMENDMENT 8
TECHNICAL AND STYLISTIC AMENDMENTS**

The Charter Revision Commission has recommended that the Charter be amended to reflect non-substantive stylistic and technical changes made for clarity including titles, county name change and renumbering of sections.


Shall the above described amendment be adopted?

The whole number of votes cast was 2,947, of which number:

YES received 2,464 Votes

NO received 483 Votes


